Many of you had wondered why I put my little "*Cottage by the Sea*" up for sale. That is why. As soon as I knew the direction I



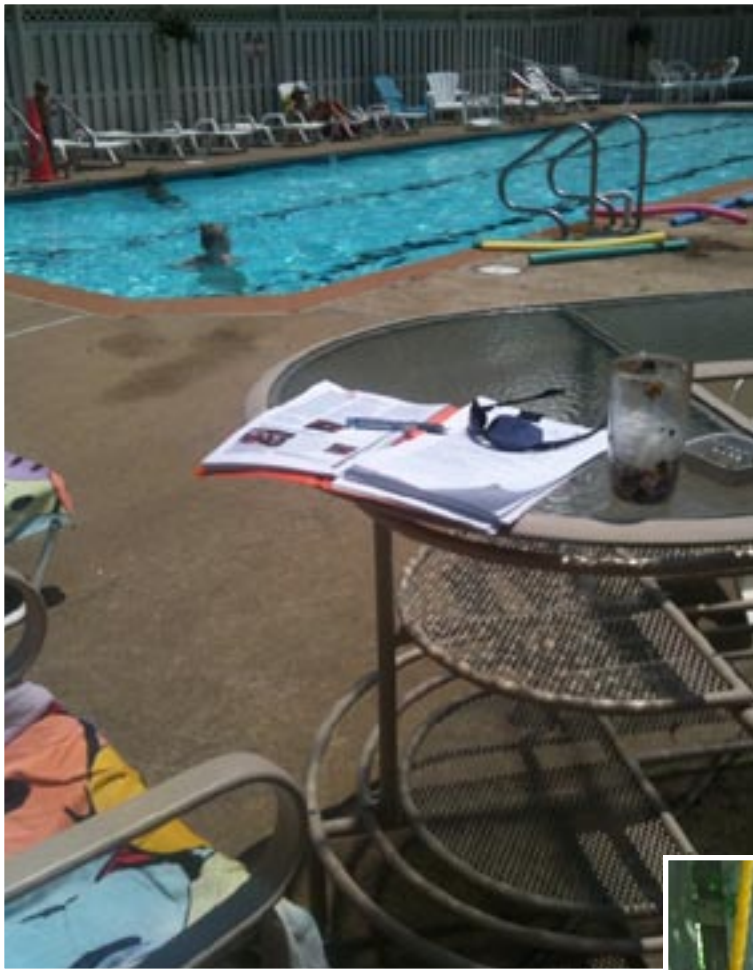
needed to go, I had my friend list her. There was a contract within days. If all goes well, it should close by mid- to late- August.

Yes, it breaks my heart, and no, I have no clue where I will be going. I still am not certain what kind of budget I will be looking at, so that complicates things just a bit.

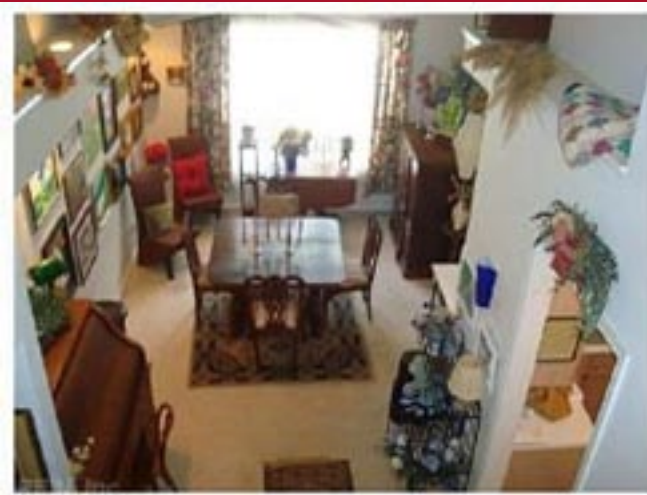
